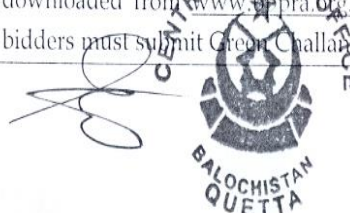

Only Manufacturers, Suppliers, Authorized dealers and well reputed firms who are registered/on Active Taxpayers List (ATL) of Federal Board of Revenue (FBR), Sales Tax, Income Tax, National Tax Number (NTN) &amp; other related Taxes are eligible to participate in the tender (documentary proof required).</li><li>b. The bidder should be eligible to supply goods/services to Government Departments and must have completed <u>03</u> assignments of similar nature of work in last 03 years (documentary proof required).</li><li>c.
