1. Procurements shall be made under the Balochistan Public Procurement Rules – 2014.
2. The Procuring Agency (Balochistan Police) may cancel the bidding process at any time prior to the acceptance of a bid or proposal in line with Rule 38 of BPPRA Rules, 2014.
3. **Eligibility of Bidders:**
 - (a) Only Manufacturers, Suppliers, Authorized dealers and well reputed firms who are registered/on Active Taxpayers List (ATL) of Federal Board of Revenue (FBR), Balochistan Revenue Authority (BRA), Sales Tax, Income Tax, National Tax Number (NTN) & other related Taxes are eligible to participate in the tender (documentary proof required).
 - (b) The bidder should be eligible to supply goods/services to Government Departments and must have completed **03** assignments of similar nature of work in last 3 years (documentary proof required).
 - (c) Turnover (Financial Capacity) as mentioned in Tender documents (documentary proof required).
 - (d) NOC from Ministry of Interior issued to the firm for carrying on bullet proofing of vehicles is must.
4. **Bid Security:** The bid must accompany Bid Security 05% of the quoted amount in the form of **Call Deposit** or **Bank Guarantee** in the name of the Inspector General of Police, Balochistan from a scheduled bank.
5. **Tender Documents:** The bidding documents can be obtained from the office of Assistant Inspector General of Police (General), Central Police Office Balochistan, Gulistan Road Quetta upon payment (non refundable) bidding document fee (amount mentioned above) deposited in government treasury under head CO-2642-Police Receipt-Others through Green Challan Form in State Bank of Pakistan (SBP)/National Bank of Pakistan(NBP).
