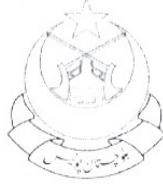

 - (b) The bidder should be eligible to supply goods/services to Government Departments and must have completed 03 assignments of similar nature of work in last 3 years (documentary proof required).
 - (c) Turnover (Financial Capacity) as mentioned in Tender documents (documentary proof required).
4. **Bid Security:** The bids must accompany Bid Security 05% of the quoted amount in the form of **Call Deposit** or **Bank Guarantee** in the name of the Inspector General of Police, Balochistan from a scheduled bank.
